#### First-aid measures

## 11. TOXICOLOGICAL INFORMATION

No adverse health effects expected if the product is handled in accordance with this Safety Data Sheet and the product label. Symptoms or effects that may arise if the product is mishandled and overexposure occurs are:

<b>Inhalation</b>	The components of the product are of low volatility and no adverse effects are expected from handling the concentrate. However, care should be taken to avoid the inhalation of excessive amounts of spray mist during field spraying, respiratory irritation may occur.
<b>Ingestion:</b>	Ingestion of the concentrate in relatively large amounts can result in headache, nausea, lethargy, motor weakness and unco-ordination. If aspirated into the lung, e.g. from vomiting, the presence of surfactants may result in chemical pneumonitis or other lung damage.
<b>Skin</b>	Prolonged contact with the concentrate may cause irritation. Prolonged contact with the concentrate can cause defatting of the skin and may result in dermatitis. Prolonged contact with the concentrate may result in absorption of glycol ether in harmful amounts.
<b>Eye</b>	The concentrate may cause irritation of the eyes unless washed off immediately

<b>Chronic Effects</b>	No information available, no chronic effects expected.
