STOCK and DOMESTIC ANIMALS:

Ensure livestock and domestic animals cannot access baits. Do not return stock to treated areas until all baits have been removed from the area. Where practical minimize non-target animals from consuming poisoned carcasses either by collecting carcasses and disposing them by burning or burying below 500mm of soil (wherever feasible), or by limiting their access to the baiting site until carcasses are unlikely to be edible or contain residues.

TREATMENT OF DOMESTIC ANIMALS:

Vitamin K1 is an effective antidote against accidental poisoning of domestic animals by Pindone.

DIRECTIONS FOR USE:

POSSUMS: Use bait stations placed out of the reach of stock and refill at four day intervals maintaining an uninterrupted supply. Bait stations should be placed along bush borders at intervals of no more than 100 metres and preferably x 50 metre intervals. In bush situations bait stations should be placed at 100 metre intervals. Stations should be sited in all areas of possum sign e.g. scratchings and droppings, near den sites and preferred food sources, and at the foot of leading ridges where possums prefer to travel and bush/pasture margins. Ideally a suitable bait station will have the ability to hold 2 kilograms of pellets.

RATS: Bait stations should be placed at intervals of no more than 100 metres and preferably at 50 metre intervals.

Low infestation: Place 150 grams into a bait station and maintain an uninterrupted supply of fresh bait for at least 10 days or until signs of rat activity cease.

Medium to high infestations: Place 1 to 2 kilograms into a suitable tamper-resistant rat bait station and maintain an uninterrupted supply of fresh bait for at least 10 days or until signs of rat activity cease.

NOPESTS Multifeeder and Pied Piper bait stations are suitable for use when baiting with pellets and are readily available from Key Industries Ltd.
