Situation	Rate/100m ²	Rate/Ha	Comments
Sportsturf	50mL	5L	Apply the product in 500-1000L of water/ha. Ideally the product should be applied the day before dew control is required. Dew control will persist for up to 5 days. After this time, another treatment is required.

TANK MIX FLEXIBILITY

Tank Mix Combinations with Stamina Dew-Star have not been tested on all varieties under all possible growing conditions. If the user is unsure a limited area should be treated and a reasonable judgement and caution should be exercised. A jar test is recommended prior to broad scale use.

STORAGE AND DISPOSAL

KEEP OUT OF REACH OF CHILDREN. Store in original containers in a well ventilated area. DO NOT store for prolonged periods in direct sunlight. Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on site. If recycling replace cap and return clean containers to recycler or designated collection point. Empty containers and product should not be burnt.
