GENERAL INFORMATION

Bullseye[®] Blue Spray Pattern Indicator is designed for use in forestry and industrial weed control applications such as baregrounds, rights-of-way, forestry, handgun and spot spraying. Bullseye provides visual assurance that these solutions are uniformly applied, with minimum overlap and no missed areas. Bullseye helps to alert the operator to improper equipment operation as well as improves safety during application by increasing user awareness during and after the application of potentially hazardous chemicals.

BULLSEYE IS NOT PERMITTED FOR USE ON EDIBLE CROPS

DIRECTIONS FOR USE

Mix all pesticides as recommended prior to the addition of Bullseye Blue Spray Pattern Indicator. Mild agitation is required after the Bullseye Blue Spray Pattern Indicator is added to the pesticide mix.

HEALTH HAZARD AND FIRST AID INFORMATION

Avoid contact with eyes and skin - may cause temporary irritation. In case of contact, flush eyes/skin with large amounts of water. If irritation persists, seek prompt medical attention. Do not ingest. In case of ingestion, drink copious amounts of water and seek prompt medical attention.

STORAGE AND DISPOSAL

Store in a closed container. Do not reuse container. Small spills

can be washed away with water. Large spills should be contained and salvaged. Disposal must comply with local, state, and federal regulations.

- Reduces excessive overlap and misapplication of pesticides and fertilizers.
- Environmentally conscious.
- Increases the awareness during and after the application of hazardous chemicals.
- Color is temporary and easily dissipates with environmental exposure.
- Non-staining on most skin, clothing, and hard surface applications.
- Cleans up with soap and water.
- Aids in spotting drift, clogged nozzles and other spray equipment malfunctions.
- Inert with most pesticides.
- Completely water soluble.

For other applications, consult your distributor or Milliken Chemical. Bullseye Blue Spray Pattern Indicator may be sprayed as an indicator in aquatic applications with the exception of drinking water.

Rights-of-way: grasses & broadleaf weeds	10-14 oz; 300-425 ml	100 gallons; 400 liters
Forestry, handgun	16-32 oz; 475-950 ml	100 gallons; 400 liters
Spot spraying	1 oz per gallon; 10 ml per 1 liter	1 gallon; 1 liter
