## A-TEP with Mg, Fe, Mn, Zn, Cu

- 9.0% Total Sulfur (S) from sulfate
- 0.5% Copper (Cu) from copper oxide
- 12.0% Magnesium (Mg) from magnesium oxide
- 8.0% Iron (Fe) from ferric oxide
- 3.0% Manganese (Mn) from manganese oxide
- 1.0% Zinc (Zn) from zinc oxide

**Directions for use:** Apply product to actively growing turf at 7-11 g/m<sup>2</sup>. Apply to dry foliage. Water in after application with 5 to 6 mm of irrigation prior to any traffic to aid particle dispersion and reduce potential for staining. If temperatures exceed 30°C or if application to damp or wet turf is unavoidable, irrigate immediately after application. Apply at low rates if temperature exceed 30°C. This product contains iron which may stain concrete and other surfaces. Remove particles promptly by sweeping or blowing to avoid staining. **DO NOT WASH OFF WITH WATER.** Store in a clean, dry place. Reseal opened bag by folding top down and securing. Use only clean, dry spreaders. Do not leave unused product in spreaders.
